Project Overview:

The Adult Library is undergoing a renovation to transform it into a quiet, comfortable space for studying and reading. The project aims to improve seating capacity, update outdated furniture, and optimize the layout for better space utilization.

Project Goals:

- Create a quiet, cozy, and comfortable environment.
- Increase desk/table seating from 13 to 20–25 seats.
- Maintain at least 18 reading chairs.
- Improve layout efficiency while preserving current functionality.

Scope of Work Desired:

- Replace outdated reading chairs and study carrels.
- Add counter-style seating and two four-person tables
- Relocate and adjust shelving to create more space.
- Install new magazine and newspaper shelves around concrete pillar.
- Ensure furniture aligns with existing design themes and color palettes.

Current and Potential Roadblocks and Barriers to Success:

- Structural limitations due to immovable support beams.
- Existing bookshelves may not be easily split or relocated.
- Study carrels take up excessive space.
- Some seating areas are underutilized due to layout and lack of privacy.

Proposal Evaluation Metrics and Criteria:

- 1. Alignment with design goals and space constraints.
- 2. Quality and durability of proposed furniture (at least 10-year lifespan preferred).
- 3. Aesthetic compatibility with existing library design.
- 4. Creative use of space and multi-functional furniture.
- 5. Cost-effectiveness and feasibility of implementation.

Submission may be in softcopy submitted electronically via email. Upon receiving the submission, TAC will inform the proposer to acknowledge receipt of the submission. It is the responsibility of the Bidder to ensure that the proposal is received by TAC, by the date and time specified. Late proposals will not be considered.

Proposal Contents

Proposals in English is mandatory. At a minimum, the proposal must include:


- Detailed layout and design plan that meet the fire-related regulations.
- Furniture specifications and material samples.
- Timeline for project completion.
- Budget breakdown.
- Maintenance and durability expectation.

Bidder must be an interior furnishing vendor that is legally registered and authorized to operate and services in Japan.
